**PROMOTION:**

Chief Don DeAngelis recommended that part-time Firefighter Mark Proulx be promoted to the rank of Lieutenant. This promotion is to fill a vacancy in that position.

**Motion by Selectman Cody Belanger to approve the promotion of Mark Proulx to the rank of Lieutenant with a pay increase of \$.50 per hour. Seconded by Selectman Mike Yergeau. Motion carried 3-0.**

**FULL-TIME HIRE:**

Chief Don DeAngelis recently advertised to fill a full-time vacancy with the departure of Paul Hanley. He did receive only one application from a current part-time member of the Department. He recommends part-time Firefighter Donald Tilbe to be a full-time Firefighter. He has been in the fire service for 14 years and has been with the Epping Fire Department part-time for approximately 18months. His current certifications qualifies him for full-time employment on the Fire Department. His full-time duties would begin sometime within the first two weeks of January. Mr. Tilbe is a resident of Fremont, NH. Starting date will be January 7, 2019 and rate of pay is \$19.00 per hour.

**Motion by Selectman Cody Belanger to approve the status of Firefighter Donald Tilbe from part-time to full-time Firefighter effective January 7, 2019 with a starting pay of \$19.00 per hour. Seconded by Selectman Mike Yergeau. Motion carried 3-0.**


**Motion by Selectman Cody Belanger to adjourn the meeting. Seconded by Selectman Mike Yergeau. Motion carried 5-0.**
